InfraGard is partnership between the FBI and members of the private sector. The InfraGard program provides a vehicle for seamless public-private collaboration with government that expedites the timely exchange of information and promotes mutual learning opportunities relevant to the protection of Critical Infrastructure. With thousands of vetted members nationally, InfraGard's membership includes business executives, entrepreneurs, military and government officials, computer professionals, academia and state and local law enforcement; each dedicated to contributing industry specific insight and advancing national security. Today, there are approximately 50,000 members in 84 local InfraGard Member Alliances (IMAs) represented nationally by the InfraGard Members Alliance (INMA). Each IMA is connected to a FBI Field Office.

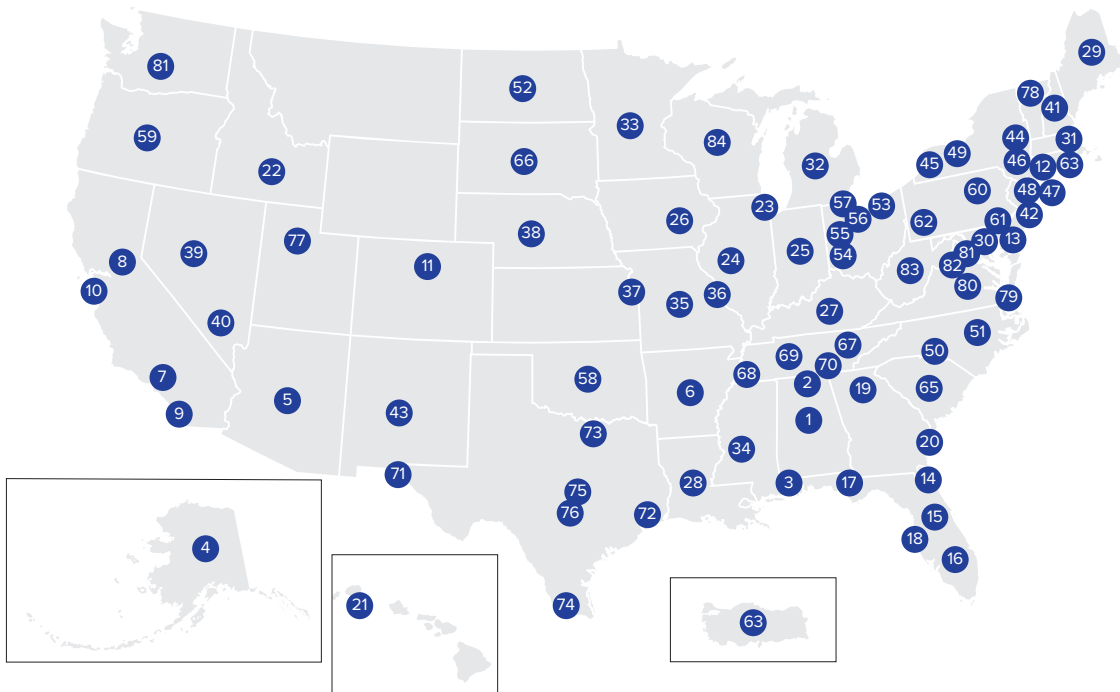
### Goal:

- U.S. citizen, 18 years or older
- Consent to an FBI security risk assessment and periodic re-certifications
- Notify the FBI of any pending criminal matters
- Sign and adhere to a Confidentiality and Non-disclosure Agreement
- Agree to adhere to InfraGard Code of Ethics
